



#### (\*\*) PRODUCTION, BUSINESS AND SERVICE SECTORS PERMITTED TO OPERATION



Shopping malls, supermarkets, mini supermarkets, convenience stores, grocery stores, wholesale markets, traditional markets



Only take away orders are permitted: Food and beverage establishments



Restaurants within lodging establishments, resorts and tourist attractions may serve their guests and must not serve buffets





- ≤ 50 % of their capacity
- ≤ 10 people at a time

Barbershops, hair salons, sports facilities (gyms, yoga classes, etc.)



Operations of representative offices and branches of foreign traders in the city






COMBINATION OF ABOVE MODELS










## VACCINATION (≥18yo)
